### New ETHICS Continuing Education Requirements Effective January 1, 2010

The Illinois Department of Insurance has determined that the **NEW ETHICS CE CLASSROOM REQUIREMENT**, contained in HB 70, must be completed before your renewal in 2010.

**If your license renews in 2010, you MUST have completed 3 hours of CLASSROOM ETHIC PRIOR to your renewal date or pay a \$180 penalty fee.**
